## Important Deadline: Transition to 2021 ICC Building Codes

The Pennsylvania Review and Advisory Council (RAC) has completed its review of the 2021 ICC codes and has recommended them for adoption anticipated on July 13, 2025. See the attached link for specific modifications as recommended by the Council.

State law (Uniform Construction Code) still provides for the 6 month 'grace period' wherein a permit can be applied for 6-months beyond the effective date providing a signed design contract exists prior to that date. These recommendations do not address the accessibility sections of any code, and as such PA will continue to enforce the 2018 sections of these provisions. State law has to be altered in order to adopt any updated accessibility codes.

The recommendations of the RAC will not be official until the Secretary of Labor and Industry makes them official.

## **Mandatory Continuing Education will not take effect this** year

AIA PA reminds members, that while Act 144 has been signed into law, the **Continuing** Education requirements will not take effect with the June 2025 license renewals.

The timeline for implementation remains undetermined as the regulatory process is just beginning.
