Application deadline is June 6th.

AIA Pennsylvania is also proud to fund registration and travel for the annual Women's Leadership Summit (WLS) through the WLS Scholarship. The Summit, founded by AIA, supports and empowers women in architecture, design, and the allied building industries. Application deadline is June 9th.

AIA Pennsylvania celebrates the great work that Pennsylvania's architects are doing to affect positive social, environmental, and economic outcomes for their clients and communities. The Architectural Excellence Design Awards celebrate the exemplary design achievements of members and the impact of architecture regardless of budget, size, style, or type. Submissions open June 2nd.

The **Paula Maynes ARE Grant** recognizes architecture graduates pursuing licensure and their contributions to the profession and their greater communities by offsetting the costs of the Architect Registration Examination (ARE). Established in 2015, the grant celebrates the late Paula Maynes, AIA, whose collaborative character and legacy of mentorship and service to the profession left an indelible impact on the architecture community. Applications open in June.

Lastly, the **EPiC Firm Recognition**, facilitated by the Emerging Professionals Committee (EPiC), recognizes firms for their commitment to the professional development of emerging professionals and young architects with an assessment of firm culture and support in four critical areas: (1) licensure, (2) leadership and professional development, (3) career advancement opportunity, and (4) commitment to equity, diversity, and inclusion. AIA National: Tell Congress to Support Freedom in Design

Architects understand that design choices shape how people interact with public spaces —and those choices should reflect the needs, values, and character of the communities they serve. When the federal government imposes narrow design mandates, such as requiring neoclassical styles for public buildings, it limits innovation, sustainability, and local input.

Instead, federal building design should be guided by professional expertise, community voices, and forward-looking principles like resilience and accessibility. Congress has the power to protect design freedom and promote policies that reflect modern challenges and opportunities.
